**BEE GREEN RECYCLING & SUPPLY, LLC APPLICATION TERMS AND CONDITIONS**

It is agreed by the Applicant and Bee Green Recycling & Supply (BGRS) and its subsidiaries that any sales or extension of credit by BGRS to Applicant shall be subject to the following terms and conditions.

1. Payment terms are Net 30. All invoices are subject to interest at the rate of one and one-half percent (1.5%) per month on all past due balances.
2. The Applicant shall pay for all costs and expenses of collection of amounts due under this Agreement, including reasonable attorneys' fees, court costs and expert and consultants' fees.
3. All sales under this Agreement are subject to our standard return policy, which may be changed from time to time without notice in the sole discretion of BGRS. All sales are FOB BGRS store locations unless delivery service is selected at time of service or purchase. See terms and conditions listed on BGRS websites.
4. The Federal Equal Credit Opportunity Act ("ECOA") prohibits credit grantors from discriminating against credit applicants on the basis of race, color, religion, national origin, sex, marital status, age (provided the applicant has the capability to enter into a binding contract), because all or part of the applicants income derives from any public assistance program, or because the applicant has in good faith exercised any right under the Consumer Credit Protection Act. The federal agency that administers compliance with this law concerning this credit grantor is the Federal Trade Commission.
5. This Agreement shall be deemed accepted and performed in Alameda County, CA, USA. The parties hereto agree that any disputes under this Agreement shall be governed by California Law and exclusively submitted to the courts of Alameda County, CA for adjudication.
6. The undersigned individual who is either a principal of the credit applicant or a sole proprietorship, represents and warrants that he/she is authorized to enter into this credit application on behalf of credit applicant and recognizes that his/her individual credit history may be a factor in the evaluation of the credit history of the applicant, hereby consents to and authorizes the use of his/her consumer credit report to the above named business credit grantor, from time to time as may be needed, in the credit evaluation process.
7. BGRS shall not be liable for any loss, claim, expense or damage caused by, contributed to or arising out of the acts or omissions of applicant or third parties, whether negligent or otherwise. In no event shall BGRS' liability for any cause of action for any matter arising out of this credit application or BGRS' sale of goods or services to applicant whatsoever exceed the cost of the product or service giving rise to the claim, whether based in contract, warranty, indemnity or tort (including negligence and strict liability) or otherwise. In no event shall BGRS be liable for any special, incidental, consequential, exemplary, punitive or other such indirect damages (including, without limitation, loss of revenues, profits or opportunities) whether arising out of or as a result of breach of contract, warranty, tort (including negligence and strict liability) or otherwise.
8. Express warranties, if any, provided with products or services sold by BGRS shall be as set forth in the associated product documentation. BGRS specifically disclaims any and all other implied warranties, including warranties of merchantability and fitness for a particular purpose, none of which shall apply to the sale of BGRS' products or services.
9. Applicant agrees to immediately notify BGRS' of any change in ownership, address, authorized purchaser(s) or form of said applicant in writing. This Agreement shall remain in force until the account is paid in full and written notice of termination of this Agreement is received by BGRS.
10. Applicant hereby grants BGRS consent to and authorizes all vehicles included above to charge Applicant's account. Applicant is responsible for all charges made by an authorized vehicle. Additional authorized vehicles may be added by Applicant via a written request. Applicant understands that this authorization will remain in effect until cancellation is given in writing.
11. BGRS reserves the right to terminate this Agreement at any time, with or without notice, for any reason, at its sole discretion.
12. THE APPLICANT, THE GUARANTOR(S), AND ANY OTHER PERSON SIGNING THIS AGREEMENT, EACH REPRESENT AND WARRANT THAT THE INFORMATION SUBMITTED IS TRUE AND CORRECT IN ALL RESPECTS.
