**\*City of Oakland charges a \$34.50 Franchise Bin Set Fee;** This fee is passed thru to customer on bin sets in Oakland.

**City of Alameda charges AB939 & Infrastructure Mitigation Fee \$13.77/ton.** This fee is passed thru on bin sets in City of Alameda.

For all bins outside City of Oakland or City of Alameda, we charge an additional \$50 delivery fee above the Base Fee.

**Mixed C & D (Construction and Demolition) Debris Allowed:** Building materials, lumber and wood, gypsum wallboard, glass, metal used in construction, roofing materials, tile, carpet, pad, and other floor coverings, window coverings, plastic pipe, concrete, bricks, fully cured asphalt, HVAC systems & components, lighting fixtures, furnishings and fixtures, tools, blueprints, plans, packaging materials from building materials/tools, plant materials from commingled C&D work, household appliances have an additional fee of \$40.70/ each and refrigerated appliances \$52.30/each.

**Prohibited Materials:** MSW, household garbage, yard, garage, home or business clean outs, food, green waste, any liquid, smelly materials, clothes, any hazardous materials, asbestos containing materials (ACM), treated wood, light bulbs including fluorescent lights, ballasts without the words "Contains no PCBs", wet paint, batteries, e-waste, automobile parts, tools with gas or oils, infectious wastes (i.e. medical), empty containers larger than 5 gallons.

**Inerts:** Concrete, asphalt, brick, and other inerts.

**Clean Dirt:** Dirt, sand or soil. A soil analysis may be required. No sod, grass, large roots or contaminants.

**Mixed Inerts:** Any inerts mixed with clean dirt.

**Clean Wood:** Pallets, lumber, plywood, nails, small fasteners (no painted, stained, or treated wood).

## Terms of Service/ Acknowledgments:

**Clearance.** General placement of bin requires 10' width, 40' length, and 25' above clearance for the truck to load and unload the bin. Bins range from 2-8' tall, 8' wide, and 18'-22' long. Driver may refuse service if there is not enough clearance, including space for truck to maneuver. Driver may refuse service due to slope or other site conditions, wherein a trip charge may be levied (see below). Customer is responsible for securing and maintaining placement of bin.

**Bin Pick-Up.** Customer will call for bin pick-up/swap as needed. Bin fees allow for up to **7 days** of use. A **\$25/day** fee is charged for every day beyond the 7 days. Delivery or pick-up times are not guaranteed.

**Fees.** If Bee Green Recycling & Supply, LLC ("Bee Green") is not able to pick up a bin due to overweight, unbalanced loading, blocked access, general safety, etc. Customer agrees to pay a trip charge (\$165 and up depending on location). Customer is responsible for unloading and/or reloading materials as needed. If driver must wait on site for more than 20 minutes for any service, Customer will be billed \$2.50/minute demurrage fee beyond original 20 minutes. An overage fee will be calculated and charged for weight in excess of the amount included with the original bin fee as listed under "Bin Selection Information" (page 1).

**Payment.** A base fee will be collected prior to bin service (see page 1 "Bin Selection Information"). Any other fees will be collected upon invoice. Customer authorizes Bee Green to charge any payment method Customer has submitted previously to Bee Green. If Bee Green does not receive payment in full on any invoice upon receipt, late charges at 1.00% interest per month (12% per year) will be imposed on your unpaid balance after 30 days.

Customer is responsible for full payment of bin service. Customer agrees to pay any additional amount incurred (as a result of trip charges, extra time per-diem fees, overage fees, costs related to prohibited materials, damage repairs, fees/penalties etc.), and hereby authorizes Bee Green to charge the extra amounts to any payment method on file.

Customer agrees to pay any collection fees and/or reasonable attorney's fees that may be incurred by Bee Green, to collect on any debt outstanding.

**Damage or Theft of Bin.** If the bin sustains damage or theft while at the specified location, the Customer agrees to pay for repairs or replacement of any damages that are sustained by Bee Green due to the company's loss of use of the bin.

**Prohibited Materials.** Prohibited materials listed under "Prohibited Materials" (page 1) are not allowed in any bin. Customer is responsible for use of the bin and all of its contents. Customer shall prevent prohibited materials from being placed into bin and shall remove or be responsible for cost of removal of prohibited materials if discovered in bin.

**Cancellations.** Bee Green requires 24 hour notice to cancel a requested bin service without liability for a cancellation fee. If the Customer cancels with less than 24 hours notice, Customer agrees to pay a cancellation fee of \$200.

**Acknowledgments.** Customer has property owner's permission and/or any required permits to place a bin for service at the location specified. Any fees/penalties levied against Bee Green for setting a bin at the specified location will be reimbursed by Customer.

Customer understands that service location may sustain damage as a result of services performed including but not limited to damage to landscaping (trees, lawn, sprinklers, hardscapes, decorations, etc.), utilities (above and below grade), fencing, overhead obstructions, etc. To the full extent allowed by law, Customer agrees to indemnify and hold harmless Bee Green, its employees, agents, officers, owners, or assigns from any liability for claims, damages, losses, and expenses, including reasonable attorney's fees resulting from the performance of the requested service(s), or any act or omission. This includes but is not limited to (a) any personal injuries (including death), whether the same be injuries to Customer's employees, agents, contractors or assigns or other persons, or (b) damage to any type of property (including real, personal, or business property), or (c) for costs, fees, taxes, penalties, or expenses which may occur as a result of bin service (including but not limited to placement, use, transportation, storage and removal). This paragraph shall survive the termination or expiration of this Agreement.

Bee Green will only provide recycling bins where permitted by law, regulation, or ordinance. Customer is responsible for checking with local regulations before contacting Bee Green for bin service.
