### Acknowledgments/Terms of Service:

- 1) Customer has property owner's permission and/or any required permits to place a recycling bin at the location specified. Any fees/penalties levied against Bee Green Recycling & Supply (Bee Green) for setting a bin at the specified location will be reimbursed by Customer.
- 2) Customer has sufficient means to warrant, and agrees to indemnify Bee Green or any of its affiliates or service providers for any damage to property or injuries or accidents that may occur as a result of bin service (including but not limited to placement, use, storage and removal). Bee Green will not be responsible for pavement markings, road surfaces, sod, lawn, asphalt, landscaping, fencing, overhead obstructions, etc.
- 3) Customer is responsible for filling the bin and its contents. Bins must be loaded evenly and level with nothing extending higher than the sides of the bin. The maximum legal weight allowed to be hauled is 10 tons (20,000 lbs). Overweight loads are subject rejection and are to be reloaded by customer.
- 4) If Bee Green is not able to pick a bin due to overweight, access to bin, etc, Customer agrees to pay a trip charge (\$165 and up depending on location).
- 5) Customer will call for Bin pick-up/swap as needed. Bin fees allow for up to 7 days of use.
- 6) If the bin sustains damage while at the specified location, the customer agrees to pay for repairs or replacement.
- 7) An Overage fee will be charged for weight in excess of the amount included with the original Bin fee.
- 8) Customer is responsible for full payment of bin and a \$100.00 security deposit. Your deposit will be returned as soon as the load is processed. However, if the weight of the bin exceeds the limit, or there are unacceptable materials in the bin, this deposit will be used to off-set these additional fees. If the deposit is insufficient to cover any additional fees, customer agrees to pay the additional amount, which may be charged to any payment method we have on file.
- 9) Customer agrees to pay any collection fees and/or reasonable attorney's fees if necessary to collect on any debt outstanding.
